To whom is Personal Information shared and transferred?

How is Personal Information Collected?

Your personal information may collected when you make reservation through our web site, mobile app or worldwide reservations offices and hotels; during your stay at hotel; when you are on our web site and mobile app or through any verbal or written method.



What are your rights?

You have right to; 1. Learn whether or not your personal information have been processed; 2. Request information as to processing if your data have been processed; 3. Learn the purpose of processing of the personal information and whether information are used in accordance with their purpose; 4. Know the third parties in the country or abroad to whom personal information have been transferred; 5. Request rectification in case personal information are processed incompletely or inaccurately; 6. Request deletion or destruction of personal information within the framework of the conditions set forth under article 7 of Turkish Law on the Protection of Personal Data no. 6698; 7. Request notification of the operations made as per indents 5 and 6 to third parties to whom personal information have been transferred; 8. Object to occurrence of any result that is to you detriment by means of analysis of personal data exclusively through automated systems; 9. Request compensation for the damages in case the person incurs damages due to unlawful processing of personal information.
